- Provision of extensive green space.
  - Green habitat links
  - Ecological management plan
- Provision of a network of inclusive children's play areas.
- Playing pitches to support Barton Park and Barton.
- Indoor sport contribution.
  - Potential for on-site or supporting local facilities

### Sustainability

- Integrated pedestrian and cycle connectivity with Barton and Barton Park.
- Green cycle and pedestrian first street hierarchy within the site.
- Improved pedestrian and cycle routes towards the city and key employment areas.
- New and improved bus links.
  - Oxford is aiming to be one of the first all electric bus cities.



#### Sustainability

- Undertaking Travel Planning initiatives potentially to include:
  - Electric Car Club
  - E-bike hire
  - Cycle café
  - Cycle training
- Site design to include EV charging facilities.
- Provision of homes in accordance with Local Plan Policy on carbon emission reductions – as set down in DES 10.
- Hydrological measures for the site allow for climate change.



### Sustainability

### Affordable Housing

- Edge of Oxford site with 50% Affordable housing (40% for non-Oxford sites) in line with Policy H9
  - 35% Social Rent
  - 40% Affordable Rent
  - 25% Shared Ownership
- Desire for affordable housing to include Key Worker housing of appropriate tenures to be agreed with councils.
- Desire to see an Allocations policy for the site to be agreed with the councils:
  - Priority for those who currently live locally to the site
  - Priority for those who work closest to the site
  - Maximising use of the site's sustainable location next to Headington and the hospitals.
